INTRODUCTION

BACKGROUND

The First World Conference on National Parks is being held at the Olympic Hotel, Seattle, Washington, U. S. A., June 30, July 7, 1962. The Opening Ceremony and First Plenary Session are being held at the Playhouse, located on the grounds of the Seattle World's Fair. The Conference is sponsored by the International Union for Conservation of Nature and Natural Resources; co-sponsored by the United Nations Educational, Scientific and Cultural Organization (UNESCO), and the Food and Agriculture Organization (FAO), in association with the National Park Service and the Natural Resources Council of America as national co-sponsors.

In Poland, where the IUCN Seventh General Assembly was held in 1960, the resolution calling for the First World Conference on National Parks to be held in Seattle was unanimously adopted. This followed the original proposal for such a conference which was made by Dr. Tsuyoshi Tamura of Japan at the IUCN Sixth General Assembly in Athens in 1958.

The purpose toward which Dr. Tamura and other IUCN leaders around the world are striving is to achieve a more effective international understanding and encouragement of the national park movement on a world-wide basis. National parks and reserves have been established in most United Nations member countries, and they are internationally recognized as a form of wise land use that contributes to the inspiration and general welfare of all mankind. They are indispensable to the cultural, scientific, recreational and economic needs of all nations. Their permanent preservation will safeguard for future generations the characteristic natural beauty, the native flora and fauna, and the human history and spirit of each nation. The theme of the conference is: "NATIONAL PARKS ARE OF INTERNATIONAL SIGNIFICANCE."

This first Conference to focus world attention on the subject enables representatives of governments that are responsible for administering and protecting national parks and reserves, and other qualified experts, to meet together for the further international coordination of their efforts, and to encourage the establishment of new parks and reserves.

SPONSORSHIP

The IUCN is the primary sponsor of the Conference. It is an international body composed of states, international organizations and organizations within nations, all concerned with preservation of the natural environment of man and the conservation of the world's natural resources. The Union was founded in 1948, and has its permanent headquarters at Morges, Switzerland. PARTICIPATION

Attendance at the Conference is by invitation. Governments of all United Nations member countries, as well as Governments having membership in the U.N. Specialized Agencies, and qualified governments of Territories, have each been invited to send two delegates and additional observers as they consider appropriate.

The program is so organized that each person in attendance, regardless of his category, can attend all of the principal conference activities.

With regard to contemplated field trips in connection with the Conference, these are primarily for visitors to the United States from other nations, although United States participants will be welcome if space is available. The Tours Desk at the Information Center has full information on field trips.

HEADQUARTERS

Headquarters of the Conference are at the Olympic Hotel. The Conference, aside from the Opening Ceremony and the First Plenary Session being held at the Playhouse, Seattle World's Fair, is to be held in the Spanish Ballroom of the hotel. Additional rooms are available at the hotel for special meetings.

The Local Arrangements Committee office, which is a part of the Conference Headquarters, is in charge of all information needed by registrants on post office, telephone and telegraph, travel and transportation, press services, banking and other accommodations.

REGISTRATION

Registration opens on Saturday, June 30th, 9 a.m., and will continue for as long a time as necessary. The Seattle Chamber of Commerce Convention and Tourist Bureau will serve as registrar. The Conference badge will identify and admit conferees to all functions of the Conference, and should be worn during all of the sessions. Registrants will receive the Conference packet containing all pertinent information.

A list of all those registered will be made available as early as possible during the Conference.

LANGUAGES

The languages of the Conference are English, French and Spanish. Voice interpretation during the Conference is provided in these three languages. It is permissible to speak in other languages provided the speaker furnishes interpretation into one of the languages of the Conference.

LOCAL TRANSPORTATION

The Conference is being held in the heart of Seattle, where taxi and bus transportation are excellent to all points. No special transportation facilities are being provided other than bus service between the Olympic Hotel and the World's Fair Playhouse on the morning of July second. The Monorail provides high-speed, frequent service from the downtown terminal, approximately three blocks from the Olympic Hotel, to the center of the World's Fair.

HOUSING

While it is assumed that all conferees will have made their arrangements in advance for housing, with the Local Arrangements Committee as instructed, and with the assistance of the Seattle Chamber of Commerce Convention and Tourist Bureau, and the American Express Company, housing questions may arise. All such questions should be reported at the Information Center.

COMMUNICATIONS

The Information Center handles messages between conferees. Mail, telegrams and other communications are generally handled by the hotel mail room. Conferees are advised to check the Information Center twice daily for personal messages, bulletins and other communications.

FOOD

Seattle offers a wide selection of eating places. The Information Center maintains references to a number of them, in various price ranges.

ENTERTAINMENT

The Local Arrangements Committee has various fellowship activities scheduled for the conferees. Emphasis is being placed on the desirability of giving visitors from foreign countries as satisfying an experience as the situation makes possible. Announcements and bulletins will be issued from time to time concerning social and other events. The Seattle World's Fair dominates the city this year; and conferees will find exhibits from some 35 nations, and enthralling cultural and scientific displays built around the theme: "Man in the Space Age."

On the evening of July 5 conferees will have an opportunity to enjoy a special film—showing at the Science Theater in the United States Science Pavillion.

The National Park Service exhibit at the Fair, "Parks U.S.A.", is an interpretation of the park movement of special interest to conferees.

Informal dress is appropriate at all functions.

CONFERENCE PAPERS

It is intended that the proceedings of the Conference will be published and distributed to registered conferees. At the time of registration each conferee is to receive Parts One and Two of the United Nations List of National Parks and Equivalent Reserves. Additionally, there will be a selection of the papers by the individual panelists, and also, individual government papers, for each registrant.
